



COMMISSIONER PHYLLIS SMITH  
LEGACY LIFETIME ACHIEVEMENT  
AWARD HONOREE

Phyllis S. Smith is a lifelong advocate for community, public service, and environmental stewardship whose story is deeply rooted in resilience and compassion. Born near Pittsburgh, Pennsylvania, Phyllis learned at an early age the critical connection between health and nature. As a young widow, her mother, Gertie, made the courageous decision to move her three children to South Florida so that Phyllis's severely asthmatic older brother could strengthen his lungs by swimming daily in the ocean. Those sunrise mornings on the beach—sharing breakfast beside warm saltwater—became a powerful lesson in healing, perseverance, and the restorative power of natural resources.

That respect for the natural world runs through Phyllis's family. Her brothers devoted their lives to gardening, sustainability, and caring for the land, values that continue today through the next generation. Even during her own current battle with cancer, Phyllis draws strength from nature, using fruit from her *Synsepalum dulcificum*, or “miracle fruit” tree, a gift from her brothers, as part of her healing journey.

A resident of North Miami Beach for more than 55 years, Phyllis has dedicated over 16 years to public service as a City Commissioner. First elected in 2007, she served until 2020 and, at the urging of the community, returned to office in 2022 for a new four-year term. Her political journey began unexpectedly at age 60, after being dismissed while speaking at a city meeting—an experience that ignited her determination to ensure dignity, transparency, and respect in government.

Throughout her tenure, Commissioner Smith has served on numerous city and county committees, including Economic Development, Senior Advisory, Public Utilities, and Community Redevelopment, as well as Miami-Dade County committees focused on budget, transportation, redistricting, and neighborhood improvement. She has been a tireless advocate for accountable governance, police and public safety improvements, local business growth, and expanded programs for seniors, children, and families.

Professionally, Phyllis brings 47 years of experience as a licensed real estate broker, along with extensive leadership training through state and local civic programs. A proud graduate of North Miami Senior High School (Class of 1964), she and her husband, Woody, recently celebrated their 59th wedding anniversary. Together, they have built a loving family that includes two adult children, three grandchildren, and a cherished daughter-in-law.

Commissioner Phyllis S. Smith's legacy is one of courage, service, and unwavering love for her city and The Ancient Spanish Monastery Foundation—making her a truly deserving recipient of the Legacy Lifetime Achievement Award.



## HONORING MAYOR MICHAEL JOSEPH ESQ.

Michael Joseph is an attorney and the Mayor of North Miami Beach, recognized for his principled leadership, legal expertise, and unwavering commitment to public service. He holds a Master of Business Administration from Florida International University and a Juris Doctor from St. Thomas University. Early in his career, Mayor Joseph served with the U.S. Citizenship and Immigration Services, where he helped improve immigration application processes on a national level. He is currently a practicing attorney and partner at Galbut Walters & Associates, specializing in civil rights and land use law.

Guided by strong Judeo-Christian values instilled by his parents—his father a pastor and his mother a model of diligence—Mayor Joseph has dedicated both his public and private careers to serving others. He has sponsored immigration and expungement clinics and is frequently consulted on U.S.-Haiti immigration and foreign policy issues impacting the Haitian Diaspora.

Serving on the City Commission since 2018 and now as Mayor, he is known for integrity, transparency, and inclusive leadership. His accomplishments include returning the city's water system to local control, securing millions in public grants, expanding free transportation services, strengthening ethics reforms, and helping achieve an AA bond rating to spur economic development. Mayor Joseph resides in North Miami Beach with his wife and their two children, proudly serving the community he calls home.



## CITY OF NORTH MIAMI BEACH CHIEF OF POLICE - JUAN PINILLOS

Chief Juan Pinillos is a Miami native whose life and career reflect a deep commitment to service and community. A graduate of Miami Sunset Senior High School, he began his service in the United States Army as an Infantryman, completing multiple tours before his honorable discharge in 1999. In 2000, he continued his path in public service by joining the St. Charles Parish Sheriff's Office in Louisiana as a Sheriff's Deputy and Narcotics Detective.

Returning home in 2005, Chief Pinillos joined the Miami Shores Police Department and, a year later, continued his law enforcement career with the North Miami Beach Police Department (NMBPD). Over the years, he excelled in roles including Road Patrol Officer, Field Training Supervisor, K-9 Unit Supervisor, Special Response Team member, and Honor Guard member. Promoted to Sergeant in 2013 and Captain in 2016, he led key units while earning his Bachelor of Science in Criminal Justice Management and completing advanced leadership programs such as the Southern Police Institute and the FBI Trilogy.

In 2020, he was promoted to Major, overseeing core divisions, critical incidents, and emergency operations for the City of North Miami Beach. A longtime mentor with the Police Athletic League, Chief Pinillos remains dedicated to youth engagement, community partnerships, and public safety.

He is a devoted husband and proud father of four daughters, embodying integrity, leadership, and service.





## HONORING WILLIAM A. DEAN ESQ.

William A. Dean is the Managing Partner of Ford, Dean & Rotundo, P.A., where he is widely recognized as one of Florida's leading civil trial attorneys. Born in Waltham, Massachusetts and raised in Needham, Mr. Dean earned his B.A. in History from Union College and his Juris Doctor, cum laude, from New York Law School.

Mr. Dean began his legal career at the Miami-Dade State Attorney's Office, where he prosecuted violent felony crimes and later became a founding member of the Special Prosecutions Narcotics Unit. After entering private practice, he built a nationally respected career representing victims of nursing home abuse and neglect, medical malpractice, sexual abuse, negligent security, catastrophic injury, and wrongful death. He is a frequent national lecturer on these subjects.

A Board Certified Civil Trial Attorney by The Florida Bar and the National Board of Trial Advocacy, Mr. Dean is regarded as an expert in his field. By age 32, he secured his first eight-figure jury verdict and has since recovered over \$100 million in verdicts and settlements. He was inducted into the Daily Business Review's Verdicts Hall of Fame and consistently recognized as a Super Lawyer, Legal Elite, and Top Lawyer.

Beyond the courtroom, Mr. Dean has served the community through civic appointments and bar leadership. He is also a member of the Union College Athletic Hall of Fame, having played on its 1989 undefeated football team.




## HONORING LESLIE LOEWENTHAL


## HONORING BEA L. HINES - JOURNALIST

Beatrice "Bea" Loretta Hines is a pioneering journalist whose courage, integrity, and commitment to justice have shaped South Florida journalism for more than five decades. Born on February 12, 1938, in Williston, Florida, Bea moved to Miami with her mother, growing up in Overtown and later Liberty City. She graduated from Booker T. Washington High School in 1956, laying the foundation for a life of resilience and purpose.

After marrying James Frederick Hines in 1957 and becoming the mother of two sons, Bea was widowed while her children were still very young. She supported her family by working as a maid while pursuing opportunities made possible through the Civil Rights Act of 1964. Her perseverance led to a historic milestone in 1970, when she became the first African American woman reporter at the Miami Herald.

Throughout her more than 50-year career, Bea Hines has been a powerful voice for those unheard, often saying it is her responsibility to "watch for people who can't fight for themselves." Her work addressing police brutality, profiling, and social injustice earned front-page recognition and a Pulitzer Prize nomination in 1981. She has been named one of the nation's top women columnists, received the Royal Palm Award from PRSA Miami, appeared in the documentary Instruments of Change, and had her legacy preserved by The HistoryMakers and the Black Archives of South Florida.





## HONORING DR. SETH BRAMSON

Dr. Seth Bramson is widely recognized as America's most-published author of Florida history books and the nation's senior collector of Florida East Coast Railway memorabilia, Florida transportation artifacts, Miami memorabilia, and Floridiana. His commitment to preserving Florida's heritage began more than 63 years ago and has resulted in one of the most important historical collections in the country.

Dr. Bramson's Florida East Coast Railway and transportation memorabilia collection is the largest of its kind in the world, surpassing comparable collections held by the State of Florida Museum and the Henry Morrison Flagler Museum for similar materials. Equally extraordinary is his Miami memorabilia and Floridiana collection, the largest in private hands in the United States. Together, these holdings encompass more than 1.5 million individual pieces.

Among the collection's most significant items are the largest assemblage of Florida postcards ever compiled; the most extensive archive of restricted-clientele ("Gentile Clientele") memorabilia; the oldest known piece of marked Miami memorabilia—the 1823 handwritten abstract of the "94,100 Acres of Miami"; and the oldest marked Dade County artifact, the 1878 Revenue (Tax) Collector's book. The collection also includes an unparalleled body of materials documenting Black Miami history.

In addition to his work as an author and collector, Dr. Bramson is a sought-after speaker who offers more than fifteen engaging lectures on South Florida and Florida transportation history, bringing the region's rich and complex past vividly to life.



## HONORING TICO ARMAND

Born in Haiti—one of the poorest yet historically richest nations in the Western Hemisphere—Tico Armand proudly honors her homeland's legacy as the first Black republic and a global pioneer of freedom. An international model, public figure, and dedicated community activist, Tico has transformed her platform into a force for empowerment, cultural preservation, and social change.

She is the co-founder of ReRoute 2 Purpose, an organization devoted to the healing, development, and accountability of women through transformative empowerment experiences. Through this work, Tico has helped countless women reconnect with their purpose and heal from emotional and physical trauma. Drawing from her background in modeling, entertainment, and the arts, she has emerged as a powerful voice for personal growth and self-discovery.

A passionate storyteller and published author, Tico created *The Adventures of Yaya*, a children's series designed to teach history, culture, and language, inspiring young readers to embrace their heritage. She is also the founder of PouBelAyiti, an artistic environmental initiative promoting sustainability, cleanliness, and climate awareness in Haiti, and co-owner of Atizan International, which promotes Haitian and Caribbean culture worldwide.

Currently, Tico serves as co-chair of the Greater Fort Lauderdale–Cap-Haïtien Sister City Committee and as an ambassador for SheBuilds Global, advancing reforestation and development efforts in Haiti. She is presently writing her second book, continuing her mission to celebrate Haiti's rich heritage and the unifying power of the Creole language.
